Looking Forward post Ref C

How many of us thought that with the passage of Referendum C three years ago we had solved Colorado's problems??? Rich Jones, The Bell Policy Center, and Mark Fermanich, CO Children's Campaign, will be here in Durango Wednesday, April 30 from 5:30 – 7 p.m. at the Rec Center to give La Plata County residents a progress report. They will speak on where the state's finances are headed and ask us if that's really where we want to go.

Recalling the effort LWVs and many other organizations across the state put into the campaign to pass Referendums C and D in 2004, I know many of us thought Ref C's 'TABOR 5 year timeout' would solve our problems. However, as time passed, it became apparent that other statutory and constitutional constraints have contributed to a slower recovery. Now the national housing downturn has complicated the issue.

The following conclusions are painfully apparent:

1. State services have only partially recovered from the recession earlier in the decade.
2. 2007 was probably as good as it gets in terms of service levels. Looking forward it will be a challenge simply to maintain those levels.
3. The Arveschoug-Bird formula (prohibiting budget items in the general fund from growing more than 6%/year) will remain a factor in how revenues will be allocated.
4. Extending the Ref C timeout will not result in additional revenues. The coalition projects being able to retain all projected revenues under the new cap.
5. State program budgets are interrelated and can only be addressed through a comprehensive and coordinated process. They cannot be addressed in isolation.

The Taxpayers Bill of Rights (TABOR) limits annual growth of the state budget to the rate of inflation plus the population growth. Sounds reasonable; however, it has become clear that the services that the state funds, such as health-related and prison-related services, increase at a higher rate, compounding the problem. Also, TABOR's ratchet-down effect, which limited spending to the recessionary levels of 2002-3, makes it impossible to catch up even when the economy improves as it did in 2004.

The presentation in Durango is sponsored by a number of local organizations, including It's About Kids, La Plata County Advocacy Network, LPC Health and Human Services, Durango Chamber of Commerce, Durango Adult Education Center at the Commons, Bayfield and 9-R School Districts, as well as our LWV.

Make a point to attend the discussion so you can make educated judgments when solutions are suggested. Refreshments will be served. Post the enclosed flyer on your fridge.

The League does extremely important work in Montezuma County, keeping voters of both sexes informed on important issues. Their research capacity is impressive, as is their nonpartisan advocacy in making information public. They deserve special thanks for their work in promoting local air quality monitoring.

Election Judge

Promote democracy – serve as a poll worker on Election Day! If you are a registered voter residing in La Plata County, you are eligible to serve in La Plata County. Submit your name by April 29 to the County Clerk, 382-6296. If you are affiliated with a political party, you will be vetted by that party.

Qualifications:

Willingness to serve a long (but very interesting) day from 6 a.m. to 8 p.m.
Be U.S. citizen by the date of the election at which they are scheduled to work
Be physically and mentally able to perform the duties of an election judge
Attend a mandatory half-day election judge training class prior to each election at which they work
Never been convicted of election fraud, any other election offense or fraud and
Neither a candidate whose name appears on the ballot in the precinct that they are appointed to serve nor a member of the immediate family, related by blood or marriage to the second degree, of a candidate whose name appears on the ballot in the precinct that they are appointed to serve.

Judges are paid \$20 for attending the training session and \$100 for service on election day. Some LWV members have donated their earnings to our LWV.

Newspaper in Education Institute: Electing the President

LWVUS has partnered with the Newspaper in Education Institute to publish and provide free of charge *Electing the President*. Newspaper in Education, NIE, is an international program begun in 1955 to advance the use of newspapers in schools in order to improve reading, spelling and writing abilities and current events knowledge. Ann Flatten has volunteered to coordinate our efforts within the schools and to work with the Durango Herald's NIE representative, Julio Goicoechea, with support of publisher Richard Ballantine, to make the booklet available to all the high schools in La Plata, Montezuma and Archuleta Counties.

Electing the President, based on LWVUS' *Choosing the President* and other League resources, is available as a 30-page letter-size .pdf and a 16-page tabloid supplement for printing in volume by NIE programs nationally. The Herald plans to distribute the booklet as a supplement in an issue of the newspaper this fall. This will be a wonderful service to the communities as well as to the high schools. Think Before You Ink!

The League of Women Voters of La Plata County is encouraging its members and the public to be cautious during this period of circulation of petitions for an initiative or referendum measure.

Voters will be asked to sign a variety of petitions “just to get it on the ballot so people can vote on it.” The League is telling voters, “Your signature is valuable, more valuable than your vote, considering that far fewer signatures are required to qualify a petition for the ballot than votes to pass it on the ballot. Only sign a petition that you believe belongs on the ballot.” In Colorado 76,000 verifiable signatures are required to qualify a petition for the ballot.

LWV of La Plata County lists six questions voters can ask themselves to help them determine whether or not to sign a petition:

Is it complex? Some issues can be decided by a simple yes or no vote. Complex issues may need to be thoroughly examined and debated in a legislative arena.

Is it confusing? Some initiatives are not well written or contain conflicts that may require court resolution or interpretation.

Does it belong in the Constitution? If the measure would amend the Constitution, consider whether it really belongs there. Is it a fundamental law that should be protected from change? Correcting a constitutional amendment later would also require amending the Constitution, is cumbersome and costly, and requires another vote of the people.

How will it be funded? Is it an “unfunded mandate” that would require the Legislature to take funds from other essential programs? Consider the effect on the overall flexibility of a government budget with already limited revenue. An initiative or referendum should generally create its own revenue source, and not earmark, restrict, or obligate a specific percentage of the General Fund revenues.

Who is behind it? Ask which organization or person is behind this petition.

Who is asking you to sign? Before you sign, ask to see identification of the signature gatherer. If the person is a volunteer they must display an identification badge that includes the words “VOLUNTEER CIRCULATOR” in bold-faced type that is clearly legible. If the circulator is paid they must display an identification badge that includes the words “PAID CIRCULATOR” in bold-faced type that is clearly legible and the name and telephone number of the individual employing the circulator. The signature gatherer must be a resident of Colorado, a citizen of the United States, and at least eighteen years old.

LWVUS Climate Change Grant

Our League has received one of twelve grants offered by the national LWV in partnership with Oxfam of America to present a program on issues relating to global climate change. The goal of the grant is to engage communities in dialogues and to energize citizens around the issue of climate change and the connection between challenges faced in the U.S. and those faced by other countries, in particular, how practices in our country affect climate change elsewhere in the world.

The grant will help us bring Kristen Averyt, a staff scientist with the Intergovernmental Panel on Climate Change (IPCC), to La Plata County to speak on October 23, 2008, as part of the Professional Associates Life Long Learning Series at Fort Lewis College. Ms. Averyt was one of five scientists supporting the IPCC Working Group I, which assessed the physical scientific aspects of the climate system and climate change. She will speak about the IPCC process as well as its findings. We will also arrange a number of other meetings with community members and students while she is in the area.

Additionally, Oxfam of America will supply us with a variety of other resources on climate change, including their Sisters on the Planet package, which contains videos of women in other countries affected by climate change.

La Plata County Water Issues

Jack Rogers, public works director for the City of Durango, and Peter Butler, chair, La Plata County Water Advisory Board, covered quite a range of issues when they spoke to about 20 LWV members and guests on March 19. The text of Jack Rogers' remarks can be found on our website www.lwvlaplata.org.

Jack explained the recreational in-channel diversion (RICD) rights, recently awarded to the City for Smelter Park, indicating that in the process, several upstream water users who depend on Animas River water but hadn't applied for water rights, were awarded formal rights. These rights, although junior to many other rights, will prove important should there be a call on CO River water by downstream states in the future. While RICD water rights were created in 2001, Durango's RICDs were the first the CO Water Conservation Board did not oppose. Their logic had been that when RICD rights are granted, especially close to the state line, that water may not be as easily reused for beneficial purposes downstream and will just flow on out of state. Durango's rights are the closest to the state line of any CO RICDs created to date.

Peter justified the \$500,000 Sen. Isgar has requested for a CO water rights study for the state water engineer, who will be faced with deciding how CO is to trim back its water use across the state fairly in the event of such a call on the CO River. As global warming continues, we will be faced with increased wind, increased evaporation, increased sublimation and earlier snowmelt, all reducing the availability of water.

Jack noted that when the Animas/La Plata Water Project is completed in three years, the City plans to seek voter approval for general obligation bonds to acquire our \$7 million share of the water in the project (2.5% of the total amount of stored A/LP water). The city plans an impact fee of \$5700 for each new home, called a 'plant investment fee', a portion of which would go toward investment in the water supply and to pay off the bond issue. The city has a water efficiency management plan but hasn't calculated a carbon footprint of

city water usage. Since the city's water is obtained mostly through gravity flow with very little pumping, the source of energy usage are the treatment plants. The city is not testing for pharmaceuticals or endocrine disrupters but Jack indicated that since Durango water is currently drawn from the Florida River captured in Lemon Reservoir, and thus is primarily wilderness drainage, this is probably not an issue. Once the city starts to use Animas River water the problem could present itself.

Peter indicated that the county is not in the water business with no supplies or treatment plants. However, the county has established regulations developers must follow to show their developments will have sufficient water in perpetuity. A subdivision of more than 4 lots using ground rather than surface water must prove that it does not take more from the aquifer than it consumes. As for water hauling, the county allows water hauling only for 2-lot subdivisions and only if there is no option. Collecting water on roofs from snow and rainfall is illegal in CO at present, since that practice theoretically infringes on downstream water rights.


Rural water systems: Lake Durango Water System has been converted to a Water Authority, meaning that as opposed to Water Districts, directors are appointed, and it cannot levy taxes.. La Plata West Water Authority for the La Plata River drainage (drinking water only) will be very expensive. The Water Authority is building a water intake source from the A/LP project now. Proponents of the La Plata-Archuleta Water District are collecting signatures now and expect to have the creation of the district and election of directors on the ballot in late summer. A mill levy would be set and voted on later. Water source would be Vallecito Reservoir. Jack indicated that the City of Durango is not an enthusiastic supporter of Rural Water Systems, as they tend to encourage sprawl.

Water quality issues: Various groups around the county are monitoring water quality: mercury in Vallecito Reservoir, and nutrients in the lower Animas River. The Southern Utes' are working toward 'primacy' or being able to set their own water quality standards.

Peter spoke of the Animas River Stakeholders group, which has completed 50 remediation projects valued at \$30 million for reducing heavy metal loading from abandoned mines in the watershed. He mentioned the 14-year effort stakeholders groups have been involved in to achieve "Good Samaritan" federal legislation shielding third parties from assuming liability when they take on remediation of abandoned mines, indicating that the LWV's help would be welcome. To date this legislation has been opposed by both mining and environmental interests for different reasons.

A surprising statistic is that 95% of the water used in La Plata County goes to agriculture, the remaining 5% for urban usages.
