President's Message

What is up with Colorado's budget? It seems every other day we see another \$300 million shortfall. State employees are forced to take days off and social service programs are suffering. And they say it will get worse.

Leaguers know that the Colorado budget system is broken. We've been preaching about TABOR and statutory and constitutional provisions for years. We learned at LWVCO state convention in May that Colorado is falling behind as revenues decline. A new report, *Looking Forward: Colorado's Fiscal Prospects Amid a Financial Crisis*, (which can be found at <http://www.thebell.org/node/3353/>) calculates the costs of maintaining current state services through 2012-13 and projects the amount of revenues necessary to pay for them. It isn't pretty.

Carol Hedges was our speaker in May at state convention and a researcher on the new report. She is a recognized TABOR expert and currently a senior fiscal analyst with the Colorado Fiscal Policy Institute. We invited her on a tour of Southwest Colorado, where she will speak with the community about these challenges and what must be done to fix them. Join us on Tuesday, September 1st from 7-9 p.m. at the Durango Public Library. Bring your questions for this dynamic speaker.

Don't miss our Fall Kickoff membership meeting on Wednesday, September 23rd from 12-2 p.m. at the Durango Library. Pack a lunch and come hear about education and advocacy activities, discuss membership, and learn about our website. Hope to see you there.

Legislative Action

One of the great strengths of the League of Women Voters is our ability to mobilize our grass roots organization of about 70,000 members to advocate individually for positions we have taken as a result of study and consensus by all of our local Leagues. This year, I have volunteered to fill the role of Legislative Action Chair for the La Plata League. My duties in this position include encouraging our members to take actions based on League positions on local, state, and national issues that are being debated by our elected representatives. To achieve this, I plan to periodically send state and national action alert emails to our members on topics upon which we are focused. These include but are not limited to Health Care Reform; Environment, Energy and Sustainability; Global Outreach; Voting Rights and Election Reform; Youth and Family Issues; and Immigration. I will also monitor potential actions we may wish to take in La Plata County based on our local positions.

The purpose of these alerts is to invite you to take action as individuals by contacting our representatives, and the alert will always contain instructions on whom to contact and how to do so.

My first email, which will be sent in early September, will contain instructions for you to decline to continue receiving action alerts from me, should you wish to do so. If I do not hear from you I will assume that you are interested in receiving alerts and deciding on a case by case basis to respond as suggested.

(LPEA) Round Up Foundation

LPEA Round Up is a non-profit community support foundation that uses its funds to advance and support causes that strive to improve the quality of life in our community. Round Up Foundation funds are generated by LPEA consumers who choose to round up their electric bills to the next higher dollar amount. This costs an individual household or business an average of 50 cents/month, or \$6.00/year.

A local volunteer board (of which I became a member in 2009) reviews applications, determines need and allocates funds on a monthly basis. Since 2000, the Round Up Foundation has approved LWV La Plata's grant requests to cover printing and distribution of the LWV Ballot Issues pamphlet, containing pros and cons of all state ballot issues, an important service we provide to La Plata County voters.

Update to Mail-in, Early and Provisional Ballot Report

Since the issuance in May of our report on how the county processes Mail-in, Early and Provisional ballots, an amendment has been passed to the Colorado Revised statutes that govern these processes. This amendment allows voters who have requested mail-in ballots to return their ballots to a polling place in the county in which they are registered to vote on Election Day.

Previously, if a mail-in ballot had been requested, the voter would either have had to mail in the ballot or bring it to the county clerk's office. If the voter presented himself at his precinct on Election Day with the ballot, the voter was directed to go to the Clerk's office, or to destroy the ballot and vote with a provisional ballot.

This is a welcome change for voters, but does result in some concern by the Clerk's office as additional cost will be incurred to maintain a new ballot box at each precinct, and to pick up mail-in ballots at each polling place throughout the day so that they can be processed at the County Clerk's office.

Also please note that the term "inactive-undeliverable" used in the report when the post office returns mail sent to a voter from the County Clerk's office should correctly be "inactive-returned mail" everywhere that it is used.

MSI Air Quality Forum

Mountain Studies Institute 2009 air quality forum on August 26 focused on ozone and mercury, with updates on recent activities of the Four Corners Air Quality Task Force (4CAQTF), air quality on tribal lands, and air quality jurisdictions in the Four Corners area. All presentations will be available on MSI's website after Labor Day www.mountainstudies.org.

The forum wrapped up with a panel discussion of the following question: "Given recent recorded ozone levels and the potential for the ozone standard to be lowered below the current 75 ppb, what challenges and opportunities should organizations, constituencies and citizens be focused on?" The panel, moderated by Stephanie Huss, LWV president, included Jeremy Nichols, Wild Earth Guardians; Wally White, La Plata County Commissioner; Dana Wood, BP; Doug Blewitt, consultant; James Temte, Southern Ute Indian Tribe; and George San Miguel, Mesa Verde.

Dana Wood mentioned the 4CAQTF modeling, which projected results from implementation of certain mitigation strategies on NOx and SOx emissions up to 2018, showing very little reduction on a base of approximately 50 ppb of emissions from outside our area. Doug Blewitt discussed the observation of greater than expected amounts of ozone in high altitudes, indicating the need for more study of the natural sources in high terrain.

Jeremy Nichols advocated stopping the finger pointing and getting on with solving the problems with the data we have now, despite the desires for more. Models are all we have and they keep getting better and better. George San Miguel indicated that for Mesa Verde the Clean Air Act is just one of many federal mandates they must follow and they would benefit from access to a set of best practices. Their charge is to determine the dose impacting the ecology and its cumulative effects. James Temte sees our issues as coordination of activities, emissions reduction, avoidance of ozone non-attainment, mercury deposition and visibility.

The panelists all agreed, with varying amounts of enthusiasm, that an EPA liaison/coordinator based in the Four Corners area, who communicated with all groups and jurisdictions and coordinated a holistic approach to Four Corners issues would be a plus. Panelists also agreed that long-term regional air quality planning should replace the case by case treatment each newly proposed project gets from the EPA now, suggesting that perhaps this could be part of the EPA liaison's function. All agreed that the decision to lower the current ozone level should be based only on health effects, acknowledging that the EPA has a prescriptive process per Clean Air Act and that process should be followed. A couple of panelists felt that the economic effects of a lower limit should at least be acknowledged.

Panelists encouraged citizens to hold their public officials accountable for following through, particularly on the mitigation suggestions in the 4CAQTF Report from 2007.

Four Corners Air Quality Group Update

The focus of the Four Corners Air Quality Group (4CAQG) meeting August 27 was the report of the modeling of five ozone mitigation scenarios drawn from recommendations of the 4CAQ Task Force's 2007 report. The full modeling report is available at www.4cornersair.org.

The purpose of the modeling was to determine whether various types of controls on nitrogen oxide (NOx) and volatile organic compounds (VOCs) emissions from power plants and oil and gas production units would reduce amounts of ground-level ozone and/or improve visibility at Mesa Verde. The sophisticated modeling used emissions and meteorological data from 2005 and projected results for 2018 including a do-nothing scenario. Results showed that the mitigation scenario using controls on power plants and oil and gas production for both NOx and VOCs would likely bring down ozone levels slightly, keeping us under the current EPA limit of 75 ppb. A significant problem is the large base amounts of ozone not within our control, coming from outside our area and/or from wildfire, etc. Another confounding factor is that not only is ozone produced by NOx and VOCs reacting in heat and sunlight but NOx also cannibalizes ozone in some circumstances, so as you reduce NOx, you can inadvertently increase ozone levels, creating hotspots. Visibility was slightly improved but not so much that the naked eye would notice it.

There is no doubt that the issue is very complicated and that as we struggle to stay within attainment for ozone, we don't have much flexibility due to the large amount of ozone resulting from factors outside our control. On the other hand, officials now dealing with ozone nonattainment in the Front Range assert that even bringing down ozone levels by 1-3 ppb is very significant.
