## League of Women Voters 90th Birthday Celebration

Join League members on Monday, March 15, to celebrate the 90th Birthday of the League of Women Voters of the United States.

We will gather in the North Wing, on the first floor of the Colorado State Capitol.

The League of Women Voters (LWV), a nonpartisan political organization that works to improve our system of government and impact public policies through citizen education and advocacy, celebrates its 90th anniversary in 2010. Not coincidentally, the 19th amendment to the United States Constitution that gave women the right to vote celebrates its 90th anniversary in 2010, as well.

In 1920, after a 72 year struggle, passage of the 19th amendment appeared to be imminent, and members of the National American Woman Suffrage Association met to form the League of Women Voters, the organization to educate the newly franchised women to effectively use the vote.

## LWVCO Board Announcements

- Voted to endorse the debate on the subject of “Direct File” with the Colorado District Attorneys’ Council and the Stop Direct Filing organization, pending the League’s participation in the planning process.  
[Stop Direct File is a group of Coloradans who wish to end the practice of direct file. Direct file allows District Attorneys in Colorado to charge and try a juvenile as an adult without a hearing or testimony of any kind from the offender. The group’s goal is to educate the public about direct file.]

- Accepted the positions taken by the League’s Legislative Action Committee (LAC).
- Jeannette Hillery was the first non-government chair of the Rocky Flats Stewardship Council.
- A fund-raiser to celebrate the League’s 90th birthday is planned for September 24, the night prior to League Day. The community will be invited.
- The deadline for local League responses on the sustainability concurrence is March 26.
- Approved the appointment of Karen Boster as webmaster of the LWVCO website.
- Board members completed the State League Assessment Tool by consensus. The results will be sent to LWVUS. Local League boards will be asked to complete the form at a future date to identify strengths and weaknesses.

### Leadership Retreat to Focus on League Visibility

Plan to attend the Leadership Retreat June 25-26 at the Holiday Inn in Frisco, Colorado. Learn how to increase your League’s visibility in your community. 2010 will be a big election year, and Leagues usually gain members as the public hears from us about election issues and as we hold candidate forums.

We will learn proven tactics to ask people to join the League and to help us gain more visibility. In addition, we will focus on the “how-to” guidelines of Voters Service activities. This is a great opportunity for new League board members to learn about League processes, and for returning Board members to increase their knowledge. Plan to send at least two people from your League and join the fun.

The Holiday Inn in Frisco, off I-70, will be our meeting place from Friday noon through Saturday until about 2:00 p.m. You will meet Leaguers from across the state, ask questions of LWVCO Board members, and learn from local Leaguers who have “been there, done that.”

Costs will be \$40 for the first member of a League attending the retreat, and \$75 for additional members. This price includes your shared room, three meals, all materials, and expert advice! What a bargain!

## LWVCO Legislative Conference Report

January 25 found 135 Leaguers from all over Colorado attending the annual Legislative Conference at the Colorado History Museum in Denver. President Patty Cordova welcomed all and turned the meeting over to Jeannette Hillery, Legislative Action Committee chair and organizer of the event. She was assisted in the planning of the event by Sandy Eid, LWVCO Executive Director, and Legislative Action Committee (LAC) members Sally Augden and Barb Whinery.

The first speaker, Representative Carole Murray (R-Castle Rock) spoke about voting issues and explained HB1047, which attempts to clarify the language of initiatives. Elizabeth Garner, the Colorado State Demographer, explained how population size, growth, and age affect jobs, roads, housing, education, and many other areas of state expenditures. The numbers are used by state and local governments as well as public organizations. She has been working on the Census, explaining that the distribution of Federal and State funds are based on its numbers.

One of three members on the Education panel, John Karakoulakis, Director of Legislative Affairs for the Colorado Department of Higher Education, noted that General Fund financing and tuition provides the major revenue for Higher Education, however Colorado has 65% of funding compared to its peers around the U.S.

Tracie Rainey, Executive Director of the Colorado School Finance Project, described Colorado's fall from being in the top third of funding for Education in the U.S. in 1980 to now being at the bottom of the states, getting almost \$2,000 less per pupil in state funding than the national average. Nora Flood, the Vice-president of Services for the Colorado League of Charter Schools, noted that there are 160 charter schools in Colorado with 62,000 students including 38% minority representation.

Christine Watson, the LWVCO lobbyist, spoke about the dire need to fix the PERA financial shortfall and whether Pinnacle Insurance should be privatized, providing the state with some of time revenue. Chris also touched on Campaign Finance Reform changes that may be needed based on the recent Supreme Court ruling. Health care, medical marijuana, and the initiatives that could drastically change the way Colorado funds its government.

Senator Rollie Heath (D-Boulder), who was chairman of the Interim Committee on Fiscal Stability, reviewed Colorado's Gordian Knot of fiscal restraints on the state's financial ability. He asked "Is this the state we want to live in?" A bill has passed the legislature to form a Tax Review Study by the University of Denver funded privately, the first since 1958, which may provide some answers on unraveling the knot.

The delegation stayed two nights in Denver, visiting the State Legislature on Thursday. Friday morning they attended the National Conference of State Legislators, and in the afternoon they attended the National Western Stock Show. Friday evening they met their host families at a reception hosted by Dave and Margie Robinson. The delegation stayed two nights with their host families: Rose Mary and Clif Highman, Janet and Steve Reynolds, Paul and Suze Riederer, Marlys and Phil Robertson, and Bruce MacKenzie. The delegation spent the remaining three nights at the Boulderado Hotel in Boulder. Early Wednesday morning, they left Colorado and flew to Washington D.C.

The Azerbaijanies met various elected officials representing different levels of government. They met Charles Sisk, the mayor of Louisville, during a Saturday reception. Sunday, they met with U.S. Representative Jared Polis, and in the afternoon, most of the delegation enjoyed a visit to Rocky Mountain National Park. On Monday they visited county commissioner Will Toor at the Boulder County Courthouse. Later, most of the delegation visited with county clerk Hillary Hall, while a couple of the others participated in an hour long interview by the Citizen Channel 54. Tuesday morning they visited the Left Hand Water District, and after lunch, they toured Celestial Seasonings, the largest speciality tea manufacturer in North America. Later the delegates attended the political science class of Professor Billica on the CU campus in Boulder. Tuesday evening, the delegation, host families, and League committee members, participated in an "American Potluck Dinner" hosted by Marlys and Phil Robertson.

Everyone had a great experience in bridging different cultures. It is hoped that the delegation learned about the different levels of government, as well as aspects of the American culture.

### LWV of Arapahoe Health Program by Fern Black

In a program presented November 23, 2009 and sponsored by LWVAC in association with Arapahoe Library District, T. R. Reid, author of *The Healing of America, A Global Quest for Better, Cheaper, and Fairer Health Care*, responded to questions by the 200 plus attendees about health care reform in the U.S.

The question session followed a showing of *Sick Around the World*, a film documenting Reid's visits to the United Kingdom, Japan, Germany, Taiwan, and Switzerland, to investigate the health care systems of other capitalist democracies. The system of each of these countries delivers health care for everyone at a lower cost than in the U.S. when compared as a percentage of the gross domestic product. The result for citizens of four of the countries (no figures for Taiwan) is better health—all exceed the U.S. in life expectancy and have much lower infant mortality rates.

Reid stated the bills currently pending in Congress represent "tinkering at the margins" of the U.S. system which needs fundamental change. The system began with nonprofit insurance companies that became for-profit with changed ownership.

According to Reid, the U.S. has never made what he characterizes as a "moral decision to provide health care to everyone." For those who raise the fear of a government operated health care system in the U.S., Reid pointed to the success of Medicare for American seniors and the Veterans Administration for veterans of the American military. Reid's investigations in other countries revealed no citizens are forced into bankruptcy by unpaid medical expenses.

Regardless of the decisions pending in Washington, Reid offered some hope for future change in the U.S.

## Advocacy

- The **Public Advocacy for Voter Protection (PAVP)** project is supporting the LWV of Ohio to help them accomplish the crucial task of developing and implementing an effective strategy to monitor the implementation of the *LWVO v. Brunner* lawsuit Settlement Agreement.  
This lawsuit dealt with numerous issues relating to the voting system in Ohio, including improving the administration of statewide voter database systems, improving polling place management and poll worker training.
- The League and coalition partners sent a **letter to the Senate** urging opposition to Senator Murkowski's amendment attacking the Clean Air Act.
- The **LWV of Wisconsin** is highlighted in the Wall Street Journal for their work on recusal reform. Recently the Wisconsin State Supreme Court rejected proposals to require recusal when campaign contributions exceed a certain amount. The Wisconsin League had petitioned the Court to prohibit judges from ruling on cases involving major campaign contributors.
- LWVUS President Mary Wilson visited the Carolinas last month to discuss **climate change** with media, community members and Senate staff, holding a press conference at the South Carolina State House.
- In January, League President Mary Wilson joined a coalition of groups pushing for **health care reform** at a press conference in D.C.
